## **GUEST COUNT**

Final guest count is due 7 days prior to event date and is not subject to reduction once confirmed. It is the customers responsibility to request any changes 7 days prior to the scheduled event. Client will only be charged for the guaranteed number of guests confirmed on the contract. If there are more guests attending than the confirmed guest count, the caterer will charge the client accordingly so long as the client agrees to the additional food service.

#### MENU & SERVE TIME

Our catering team will work with you on selecting a catering package that is best for your event. Serving time covers up to 2 hours, but we can stick around longer for a small up-charge. Menu selections are due 7 days prior to the confirmed event date and are not subject to change 7 days out from the scheduled catering date.

#### **CANCELATIONS**

In the event that the confirmed catering date is canceled by the customer within 30 days cancellation, the customers 50% deposit is non-refundable and forfeited.

#### **STAFFING**

Our professional staff is available upon request for \$35.00 per server, per hour.

## PERMIT REQUIREMENT

If the event is on private property, permits are usually not required. However, catered events on public property often require a local permit. It is the client's responsibility to verify that The Mad Greek truck can be parked and serve at an event site.

#### TRAVEL FEE

We service a 30-mile radius. Travel fees are required for events outside this radius and can vary depending on mileage and drive time.

## PARKING REQUIREMENT

To ensure we have enough space, we require a parking space that is 18ft long and 8ft wide with a 20ft of clearance above the truck and space to open up service window.

## SERVICE CHARGE

There will be a 10% Service Charge for all events, unless otherwise specified. This service charge is an operating fee which covers bringing our food truck to your requested location, a 2-hour service of food, set-up, and clean-up.

## **GRATUITY**

Gratuity is not included in the total price and can be applied at the end of service if desired.
